A tax rate of \$0.082673 per \$100 valuation has been proposed by the governing body of Reeves County Emergency Services District No. 2.

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for Reeves County Emergency Services District No. 2 from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that Reeves County Emergency Services District No. 2 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Reeves County Emergency Services District No. 2 is not proposing to increase property taxes for the 2025 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 16th, 2025, AT 5:30 PM AT the District's Administration Building, 2269 Ocotillo Drive, Pecos, Texas 79772.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Reeves County Emergency Services District No. 2 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Commissioners of Reeves County Emergency Services District No. 2 at their offices or by attending the public hearing mentioned above.
