
ORDER SETTING RATE AND LEVYING TAX FOR 2025

ORDER SETTING RATE AND LEVYING TAX FOR 2025

WHEREAS, Reeves County Emergency Services District No. 2 (the "District") is a governmental agency and body politic and corporate of the State of Texas created pursuant to Chapter 775, Texas Health and Safety Code to accomplish the purposes provided by Section 48-e, Article III, Texas Constitution (the "Article") on May 28, 2019, and organized on August 1, 2019; and

WHEREAS, the Article states that the District has all the rights, powers, privileges, District, functions and duties necessary and convenient to accomplish the purposes of Chapter 775, Texas Health and Safety Code, as amended; and

WHEREAS, Section 48-e, Article III, Texas Constitution allows for the levy of an ad valorem tax on property in the District not to exceed ten cents (\$0.10) per \$100 valuation for the support of the District, which has been approved by a vote of the qualified voters of the District; and

WHEREAS, Texas Tax Code, §26.061, as amended, provides that if the Board proposes a tax rate that is not greater than the no-new-revenue tax rate, the Board shall not be required to hold a public hearing or an election on the District's tax rate; and

WHEREAS, Reeves County Appraisal District ("RCAD"), the Tax Assessor and Collector for the District has prepared the certified tax roll certifying the 2025 valuation of District property and presented such information to the Board for its consideration in setting the 2025 tax rate; and

WHEREAS, the Board has received the calculations from RCAD indicating the tax rate for the current year necessary to pay future debt service and operations and maintenance obligations of the District.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF COMMISSIONERS OF REEVES COUNTY EMERGENCY SERVICES DISTRICT NO. 2, THAT:

Section 1. The Board hereby finds that prior to adopting the ad valorem tax rate for 2025, the District published the proper notice pursuant to Texas Tax Code § 26.061 because the proposed tax rate does not exceed the no-new revenue tax rate or the voter approval tax rate.

Section 2. The Board hereby levies and causes to be assessed upon all property (real, personal or mixed) subject to taxation within the District a total ad valorem tax rate of \$0.082673 per \$100 of assessed value for the year 2025, which is a 3.9% decrease in the tax rate.

Section 3. The total ad valorem tax rate is only comprised of \$0.082673 per \$100 assessed valuation for operations and maintenance purposes.

Section 4. The District's Tax Assessor and Collector shall take all steps necessary and authorized by law to collect taxes as owed pursuant to this Order. Said ad valorem taxes shall be levied, assessed and collected at the rate of \$0.082673 per \$100 of assessed valuation as provided for in Chapter 775, Texas Health and Safety Code, and all other applicable laws.

Section 5. Pursuant to law, all taxes shall be due and payable on or before the 31st day of January, 2026.

Section 6. The President or Vice President is authorized to do all things necessary for execution of this Order; and the President or Vice President is further authorized to execute, and the Secretary or any Assistant Secretary to attest, this Order on behalf of the Board of Commissioners.
